



Consent and Release of Liability for Minors – Serve Saturday

I, the undersigned parent or guardian, hereby consent to my child, _____, who is _____ years of age, participating in the activities connected with Serve Saturday, an activity sponsored by Grace Family Church, for the designated Serve Saturdays assigned to each specific Grace Family Church campus for the 2017 calendar year, from approximately 8:00 AM to 12:30 PM. I certify that my child is able to participate in these activities, including but not limited to transportation to and from Grace Family Church, feeding the homeless, playing with children outdoors and indoors, sports activities, participating in arts and crafts, cleaning parks, and repairing homes with the use of indoor/outdoor equipment in efforts of completing work projects, lifting, and exposure to the outdoor elements, street outreach, elderly (including but not limited to home and lawn care), and chemicals used for cleaning. If my child has medical conditions which may be relevant to a physician in the event of an emergency, I have listed them on the back of this page. If I cannot be reached within a reasonable period of time, I hereby authorize the adult sponsor, the Local Outreach Coordinator, or the Serve Saturday Team Leader, to make emergency medical decisions for my child. If there are activities in which I do not want my child to participate, I have listed them on the back of this page.

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF GRACE FAMILY CHURCH AND ITS EMPLOYEES AND VOLUNTEERS USE REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED IN PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD’S RIGHT AND YOUR RIGHT TO RECOVER FROM GRACE FAMILY CHURCH OR ANY OF ITS EMPLOYEES, AGENTS, OR VOLUNTEERS IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND GRACE FAMILY CHURCH HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

I further state that **I HAVE CAREFULLY READ THE FOREGOING RELEASE AND KNOW THE CONTENTS THEREOF, AND I SIGN THIS RELEASE AS MY OWN FREE ACT.** This is a legally binding agreement, which I have read and understand.
